Hoffman mentioned Nature Park might be a good location and maybe continuing on to Hahn Creek Greenway. Vandalism was a concern. Bob Campagna will research this idea further.

8. Discussion regarding pickleball courts / grant opportunity

Siders shared he was approached by a donor to provide funds for up to two outdoor pickleball courts. The City would need to finalize a location. Donor would provide concrete and the City would provide all else. Wiebel mentioned old sand volleyball court at Davis Park. Siders will investigate that location. Other site mentioned was Stonebrook Park.

9. Discussion regarding shade opportunities for outdoor patio at LBC
