7. Update on Trails discussion with Linn County Conservation and Linn County Trails

Association. Siders shared information about the meeting. Siders informed the Board that the City was getting an estimate for the trail from 10th Ave SW to Irish Lane. Siders will report back to the Board.

8. Update on Stonebrook Park. Siders shared with the Board that the entrance to the park has not been paved yet. The contractor made some errors while pouring the streets that lead to the entrance and that this will have to be rectified first.

9. Update on Sculpture Trail – Campagna announced that the number of applicants was originally low. The Committee extended the deadline and within past couple weeks more applicants have evolved. The Committee now has about 10 applicants to choose from. The City sent out a survey to the public about the sculpture park. The City received 165 responses.

10. Update on Davis Park renovations. – Siders shared with the Board that bids came in too high. The City will re-bid this project with modifications and hopes for favorable bids.

11. Master Park Plan Updates from Board Members. – Papin, Reddish, and Carl provided their reports. Campagna and Brannaman will report next meeting.
