The Mount Vernon City Council met September 5, 2023, at City Hall, 213 1st Street NW, Mount Vernon, IA. A Zoom option was available. The following Council members were present: Engel, West, Tuerler, Herrmann and Rose.

Call to Order. At 6:30 p.m. Mayor Thomas M. Wieseler called the meeting to order.

Agenda Additions/Agenda Approval. Motion made by Engle, seconded by Rose to approve the Agenda. Motion carries.

Consent Agenda. Motion made by Tuerler, seconded by Rose to approve the Consent Agenda. Motion carries.

Public Hearing

Public Hearing for the Proposed Sale of the Former Fire Station Property Located at 217 First Street NW. Mayor Wieseler opened the public hearing at 6:34 p.m. Resident Keith Huebner addressed Council and asked who the property was being sold to. Nosbisch said the property is being sold to MV Brews, LLC owned by Meridith Hoffman, Darrin Luneckas and Jamie Luneckas. Heubner stated that he disapproves of the process of buying and selling properties by a City employee and the approach the City has taken in how it dispensed this property. Mayor Wieseler closed the public hearing at 6:36 p.m.

Resolutions for Approval

Resolution #9-18-2023A: Approving Fiscal Year 2023-2024 Transfers. These transfers are fairly routine. The largest transfer is from the Sewer Depreciation Fund to the Sewer Fund to help cover the cost of repairs at the Sewer Plant. This would allow the City to not increase sewer rates beyond the current 3% annual increase. Motion made by Rose, seconded by West to approve Resolution #9-18-2023A Approving Fiscal Year 2023-2024 Transfers. Roll call all yes. Resolution passes.

Resolution #9-18-2023B: Approving the Final Plat of Stonebrook 7th Addition Phase 2 to the City of Mount Vernon, Iowa. This plat extends 3rd Street SW to the west and 16th Place SW. Motion made by Tuerler, seconded by Engel to approve Resolution #9-18-2023B Approving the Final Plat of Stonebrook 7th Addition Phase 2 to the City of Mount Vernon, Iowa. Roll call all yes. Resolution passes.

Resolution #9-18-2023C: Accepting the Public Improvement Installation for Stonebrook 7th Addition Phase 2 Subdivision. The public improvements have been inspected by the City engineer and staff is comfortable recommending their acceptance. Motion made by Herrmann, seconded by Tuerler to approve Resolution #9-18-2023C Accepting the Public Improvement Installation for Stonebrook 7th Addition Phase 2 Subdivision. Roll call all yes. Resolution passes.

Resolution #9-18-2023D: Approving the Sale of the Former Fire Station Property Located at 217 First Street NW. This resolution approves the real estate agreement between the City of Mount Vernon and MV Brews LLC. The building is being sold for the appraised value of \$67,000.00. Nosbisch said there were several factors that went into the timeline of the sale (initial interest in the building, the derecho and waiting

on insurance for the roof construction). Improvements to the building would need to start within three years and finish within five years. There is a chapter in the State law that would allow for the City to get back dilapidated buildings if these requirements are not met. Motion made by Rose, seconded by Herrmann to approve Resolution #9-18-2023D Approving the Sale of the Former Fire Station Property Located at 217 1st Street NW. Roll call all yes. Resolution passes.

Mustang Land Company, LLC (Mount Vernon Family Dentistry) will receive a five year, 70% TIF rebate.
