Background Information:

Lot B, Stonebrook Fifth Addition, is immediately adjacent to the MVCSD Athletic Complex on Lot 2, 731 Palisades Road SW and a potential emergency access point for that facility. Discussion has taken place with MVCSD administration and the district has agreed to provide maintenance of the street stub and sidewalk going forward.

Location: Lot B is located between 440 13th Avenue SW and 570 13th Avenue SW, and immediately adjacent to Lot 2, 731 Palisades Road SW in the City of Mount Vernon, Franklin Township, Linn County, Iowa. The lot is approximately 60 feet wide (north to south) by 130 feet deep (west to east), according to the plat recorded in book 7492 page 561-577 of the public record of Linn County, Iowa.
