Officers had 7,413 call for service in 2022 (7,704 in 2021). Of these calls, 2,652 were dispatched (2,864 in 2021) and 4,761were observed trip (4,259 in 2021). The department completed 309 incident reports. Of the incident reports, 3 were agency assists, 105 were Lisbon and 201 were Mount Vernon.


- New hybrid patrol car entered into service

#### POLICE DEPARTMENT BUILDING RENOVATION PROJECT

- Solar panels were installed through Red Lion Solar in 2022-2023
- Martin Gardner Architecture contracted with the City for the police department building renovation project and prepared the RFP for this project.
- Septagon Construction was awarded the bid for the project in November 2022.
- Septagon began the demolition portion of this project on 1/30/2023. The renovations are expected to be completed by 12/31/2023.







# **COMMUNITY SERVICE**



- DARE at Lisbon Community School District and Mount Vernon Community School District
- Hosted Boots vs Badges which resulted in 29 units of blood being collected

- Officers worked with Cornell College, Lisbon Community School District and Mount Vernon Community School District to update their active threat plans

# WELLNESS COALITION OF RURAL LINN COUNTY

- Coalition staff are located in the department building. This coalition works closely with other communities in Linn County that are part of the SPF Grant and CARA Grant. The coalition works with the department as well as provides community events such as educational trainings for parents and school personal.
- The police participate with in-kind contributions by providing school training, attending meetings, and holding Community Drug Drop off events.
- Police officers meet with coalition members to discuss various community safety, prevention and substance abuse related issues.
- The coalition supports Dare Education efforts in both Mount Vernon and Lisbon Schools.
- The coalition partnered with the department to host two Alcohol Awareness Event at Cornell
- The coalition did multiple drug drop events (Trunk or Treat, drug drop in April, and drug drop at Celebrate Community Fair in Lisbon.
